Disclaimer:

By registering, the participant declares that they do not suffer from any health problems that would make participation medically inadvisable or hazardous to health. The right to participate is not transferable to third parties. The organizer is entitled to make changes to the event or to cancel the event in cases of force majeure or due to official orders or for safety reasons. In these cases, the organizer has no obligation to pay compensation to the athlete. In principle, the organizer is only liable in the event of intent and gross negligence. The organizer is also liable for the negligent breach of obligations if this results in injury to life, limb or health or if a guarantee or claims under the Product Liability Act are affected. The organizer is also liable for the negligent breach of obligations, the fulfillment of which is essential for the proper execution of the contract, the breach of which jeopardizes the achievement of the purpose of the contract and on compliance with which the athlete regularly relies. In the latter case, however, the organizer is not liable for unforeseeable damage that is not typical for the contract. The above limitations of liability also apply to vicarious agents of the organizer and third parties used by the organizer in connection with the implementation of the event.

Note on data protection:

In the event of non-attendance or cancellation of the event due to force majeure or cancellation of the event, there is no right to a refund of the registration fee.
